2019-202 school budget / survey update - Dr. Melvin:

Update on James John 2019-2020 proposed budget and staffing.

Project enrollment drop – 333 from 360.

Cut in 2 teacher positions, art teacher position to four days, and hours for educational assistants.

Cut in funds for reading intervention, music, teacher collaboration support, family engagement, field trips, supplies / curriculum.

No "All Hands Raised" funding - \$20K in 2018 – 2019.

Receiving funding for 50% admin support (assistant principal or school climate specialist).

Receiving state equity funds:

50% climate specialist, 1 teacher position, 50% bilingual office support, and math intervention.

Receiving title 1 funding:

3 kindergarten educational assistants and two part time 1st grade assistants.

Full time site support instructor to cover uncovered classes – will be Temerza Mehretab.

Need support in many areas, materials, tutoring, etc., and will be worked through the PTA and look at our PTA options to fund.

2020 – 2021 funding will be higher, ideally, based on the current legislature actions.
